Hahn Estates / Smith & Hook Winery Facility Rental Agreement

To reserve a date for your event, please read and sign this agreement and mail with your deposit to:

- 1. A Security/Cleaning deposit of \$500 must be paid to secure your reservation.** Reservations cancelled within 30 days of event shall be forfeited. Deposit will be refunded following a post event walkthrough and provided no excessive post-clean-up is required. [REDACTED]
- 2. A certificate of general liability insurance for the day of your event is required.** This can be obtained through your homeowners' insurance. Insurance must cover bodily injury, property damage and host liquor liability. "Hahn Estates/Smith & Hook Winery" should be named as "additional insured" for \$1,000,000.00. A copy needs to be submitted to Hahn Estates no later than 1 week prior to your event. If you are serving alcohol, please note this with your carrier. [REDACTED]
- 3. Set-up is allowed the day of the event only, unless prior arrangements have been made.** If you will be setting up any other day, insurance must be obtained for those dates as well. Any deliveries to Hahn Estates by outside vendors must be noted. For events with more than 100 guests you will need to rent portable lavatories. **Glitter, confetti, nails, tacks, pins and staples are prohibited. Your deposit will apply if any of these items are used.** [REDACTED]
- 4. If wine will be served, we require that all wines be Hahn Estates/Smith & Hook.** You are welcome to bring sparkling wine and beer. Renter shall abide by all California laws regarding serving of alcohol. No alcohol shall be served to minors under any circumstances. [REDACTED]
- 5. You are responsible for cleaning the facility after your event.** Garbage can be disposed of in the bins located at north end of Winery behind the warehouses. Cleaning may be done the following day, if prior arrangements have been made with Hahn Estates. **Please bring your own cleaning supplies.** [REDACTED]
- 6. Live music is permitted, and A/V equipment can be rented at an additional fee.** Please advise all guests to stay away from the winery and vineyards. You will be held responsible for any damage caused by your guests. **All events must end by 9:00 p.m. with 1 hour clean up until 10:00 p.m.** [REDACTED]
- 7. Renter indemnifies and holds Hahn Estates harmless from and against any and all loss, damage, expense or liability in connection with personal injury or property damage or that of its guests, employees or contractors occurring during stated date of usage.** [REDACTED]
